182. Prayers

The Chairman opened the meeting with prayers for the work of the Council.

184. Declarations of Interest

No declarations were made.

185. Parish Matters

Councillors E.Uren and N.J.Ashcroft both mentioned complaints of dog fouling, particularly in the St. George`s Ave. area. Cllr.Roughley commented that the long-promised new anti-dog fouling signs, had not yet been displayed in Windle , but were in evidence in other parts of St Helens.
